#### 4. Overdrive Update

OverDrive released an update to the OverDrive app that prompts users to return a book once they are finished or nearly finished with it. Reminding users to return finished titles before they expire will help the collection circulate more effectively, reducing wait times and holds lines. This does not affect the desktop site nor Libby; only the OverDrive App.

Here are some specifics about how those prompts are triggered:

- If an ebook is 90% complete, or if an audiobook is 95% complete, AND 72 hours have elapsed since it was last opened, the next time the user opens the app, they will receive the prompt to return the book.

- The app only prompts for one title per day, so if multiple titles meet these criteria at one time, users won't be overwhelmed with prompts.
- This is enabled for all by default, but the user has the option to disable prompts in the app's settings. This is a prompt within the app and not a push notification.

OverDrive is experimenting to prevent completed titles from languishing on readers' bookshelves, while at the same time, prompting users in an unobtrusive way. - Andi Coffin, WiLS

- Among other features and options, WISCAT offers a way to search the catalogs of many libraries in Wisconsin and beyond. Those catalogs are searchable through WISCAT in one of two ways. The first is through the Union Catalog, a small collection of static bibliographic records that once made up the bulk of holdings searchable through WISCAT. The other way that WISCAT is able to search for and present holdings is by using the Z39.50 protocol to make live connections to catalogs. Read more.
