- 2) At 1:47 p.m. on March 17, 2020, the State of Wisconsin issued a <u>press release</u> regarding the <u>Emergency Order #5</u> issued by Governor Tony Evers, which prohibits mass gatherings of 10 people or more, beginning at 5:00 p.m. on March 17. The Division for Libraries and Technology offers the following guidance for public libraries in response to the Governor's moratorium on mass gatherings.

Libraries fall within the Emergency Order #5. If a library chooses to remain open it must **NOT** allow planned or spontaneous gatherings of 10 or more people, including staff, and **MUST** adhere to the social distancing rules of maintaining six feet between people and other public health recommendations announced by the Wisconsin DHS and US CDC. The only exemption for libraries to the number of persons rule is if the library serves as a polling place.

- 3) WiLS is working closely with OverDrive to add resources to the WI Digital Library. Yesterday, 400 Duke Classic ebooks were added. Each of these is a simultaneous access title and will be available for one year. As more options are made available, we will update you.
- 4) Regarding WISCAT, Please also **do not attempt to fill lending requests** due to the suspension of delivery service and library closures. Please either mark lending requests as Will Not Supply, or leave them in Pending, where they will move on to the next lender after your Days to Respond value has been reached.
