2. Remote Desktop Access Support For Library Staff

WVLS is beginning to roll out a scalable strategy for remote access by library staff to computer and network resources in libraries. We are focusing on the use of Splashtop Remote licensing which will enable library staff to connect to library resources from personal or library-owned computers from outside of the library. This will let staff access their work computer from home in a remote desktop manner similar to what the LEAN WI support partners use with member libraries now.

Our secondary focus will be on enabling direct access via VPN connectivity from library-owned, WVLS-managed laptops into the network.

HOW TO REQUEST ACCESS: Directors and/or managers:

- Send an email to help@librarieswin.org with "Remote Desktop Access" in the subject line.
- Indicate the number of staff for whom you'd like to request remote access support.

• We will send you a link to a Google Form to fill out for each staff member that you'd like to be able to have remote access to a staff computer in the library.
