

## 1. Libraries and Racial Injustice

- "Wisconsin public libraries are places where everyone should be safe, welcomed, and respected" is a core value of the <u>Inclusive Services Statement</u>, an interpretation of Wis. Stat. sec. 43.24(2)(k). Right now, amidst this period of turbulence and activism, it is difficult to imagine libraries being safe, welcoming, and respectful when so many have been hurt, unwelcomed, and disrespected by our society. Now is the time to take action, on every level, to move this philosophy into practice. Read more.
- As communities across the country continue to speak out against racial injustice, libraries are seeking ways to stand in solidarity, to take action, and to ensure library services and programs are equitable and safe for all. We have more work to do as a public library to make sure our services, materials, technology, facilities, and surrounding grounds in order to invite and accommodate usage and engagement by all populations. ### 2. Coronavirus Aid, Relief, and Economic Security (CARES) Act Grant Survey

LEAN WI partner systems IFLS Library System, Northern Waters Library Service, and Wisconsin Valley Library Service are polling member libraries for feedback prior to applying for CARES Act Funding being managed and allocated by the Wisconsin Department of Public Instruction. The survey went out to WVLS member library directors via the Public Library Directors email group earlier today. DPI guidelines and information for the grant <u>can be found here</u>.

The LEAN WI survey is intended to help with the initial application process to ensure all available funding is applied for and to minimize any need for revising the grant project(s) after the initial application. WVLS and our LEAN WI partners will work with member libraries to meaningfully implement system-managed projects benefiting all or groups of libraries and will make best efforts to offer guidance and support for any individual library-managed projects. We will likewise work with member libraries to review and revise the grant projects if necessary within the allowances of DPI and IMLS rules and federate statutes.

## 3. Statewide Delivery Update (from Christine Barth)

This coming week, the week of June 22, SCLS Delivery will be running their usual route Southeast, Northeast and West. They will run 2 times per week. At this time, Southwest will remain at once a week.

Minitex Delivery will resume as well. If you are holding returns for Minitex, you may send them with your other returns. Please note that Minitex is NOT open for ILL and Milwaukee County remains closed for ILL and delivery.

When sending items back through delivery, please remember to update the requests in WISCAT to "returned", but note that no new requests with the exception of photocopy requests should be created at this time.
