- (from Social Media Today) At some stage, all social media managers will have to deal with negative comments on their brand Pages or posts. Some of these comments will be from blatant trolls - people trying to hijack the conversation, and/or making loosely connected remarks based on the original post. While others will be clear and passionate criticisms of your brand and/or product. So how do you go about it? What's the best way to manage negative responses? Read more.
- (from Super Library Marketing) Orbitz Media asked content creators about the amount of time they spend blogging. They found the average blog post now takes 3 hours and 57 minutes to write. That's up 65 percent from 2014! We live in a world dominated by a relentless and never-ceasing stream of content. But libraries can't just turn off our content communications streams. Our very existence depends on our ability to educate the public about what we offer. We use our content to convince people to use the library. So, what's the solution, when your library staff is overworked, and your audience is oversaturated? Be more efficient. Read more.

7. Become a Certified Application Counselor (CAC) for the ACA

Applications are being accepted to offer financial and staff support public libraries to become Certified Application Counselor Designated Organizations (CDOs) for the 2021 Open Enrollment period of the Affordable Care Act. CDOs can certify library staff and volunteers as Certified Application Counselors (CACs) who will receive training and hands on support to assist patrons and community members to successfully enroll in health insurance during open and special enrollment periods. Up to 30 public libraries in states that utilize the Federally Facilitated Marketplace (FFM)* at healthcare.gov will receive \$1,000 to support their organization in becoming a Certified Application Counselor Designated Organization (CDO) and certifying at least one staff member and/or volunteer as a Certified Application Counselor (CAC).

<u>Apply here</u> by Friday, July 17, 11:59 pm CST. It's recommended you <u>preview the application</u> and prepare the necessary information ahead of time. The application should take 30 minutes to complete.
