

#### **Partner Programs**

For more information about these programs or services please inquire at the front desk.

**Wisconsin Department of Workforce Development:** Offers career counseling, labor market exchange, migrant worker services, call center, Office of Apprenticeship Standards, WorkKeys testing and National Career Readiness Certificate.

**Division of Vocational Rehabilitation (DVR):** DVR Counselors provide individualized employment services and counseling to people with disabilities. Counselors provide or arrange for services that enable an individual to obtain and maintain employment.

**Office of Veterans' Services:** Supports and works with partner agencies to advance veterans into the workforce through targeted business engagement and effective employment services focusing on veterans with significant barriers to employment.

**WIOA Dislocated Worker:** Provides career services to workers effected by job loss due to layoff or business closing. Career services also provided to displaced homemakers, recently released veterans and their spouses. Services assist workers in the transition to new employment and may include job search assistance, re-training, support services and on-the-job training.

**WIOA Adult:** This program is designed to provide quality career services to assist unemployed or underemployed individuals in finding meaningful indemand employment.

**WIOA Youth:** Provides career services to low-income 14-24 year olds to develop work readiness skills to increase their future employability and earning potential.

**Wisconsin Works (W-2):** Offers a wide range of employment, training and support services to help eligible families, individuals, pregnant women, and minor parents secure and maintain employment.

**W-2 Emergency Assistance:** This program provides emergency assistance for housing and energy needs.

**Wheels to Work:** Promotes employment and independence through access to affordable, reliable transportation and vehicle repair.

**NTC Learning Center:** Provides GED/HSED instruction in reading, writing, and math as well as basic computer skills training through courses and open labs.
