## 6) Marketing Toolkit Survey

As part of the <u>Libraries Activating Workforce Development Skills (LAWDS)</u> program, a statewide marketing effort will be rolled out as libraries continue to add services for their communities.

Once the majority of public libraries are again open to the public for a full, or near-full, range of services, that marketing campaign will reach out across the state to communicate with people looking for work, or scaling up their careers, or needing assistance with Unemployment Insurance. As part of that effort, libraries will be provided with an easy-to-use toolkit to help spread the message within their communities.

## 7) ARSL Conference Scholarships Available

The application window for the four ARSL conference scholarships is officially open. Interested applicants have until Friday, May 28 to <u>submit their applications</u>.

Scholarship winners will receive: complimentary registration to the full ARSL annual conference and three paid nights in the conference hotel. None of the ARSL conference scholarships require applicants to have an MLIS or other degree to be eligible. All applicants will be notified of the status of their application before the opening of Early Bird Registration on July 6.

#### 8) Summer iSchool Courses Available

Online professional development courses and webinars are now available for summer through the Information School at University of Wisconsin - Madison. Topics include graphic design, library spaces, fostering engagement, and more. Registering for a class two weeks prior to the start date gives attendees a 10 percent discount. #### 9) Badgerlink Newspaper Collections Procurement

BadgerLink currently licenses more than 60 resources within 11 broad collection areas. Each collection is a separate contract which began in 2018 and was renewed last summer, providing access through June 2022. One additional renewal is available for July 1, 2022 - June 30, 2024. However, based on feedback and consideration of the importance of newspapers, as well as the desire to break up the procurement

cycle, the Request For Proposal (RFP) process has begun for the three newspaper collections. Read more.

# 10) Emergency Broadband Updates (Repeat)

The Emergency Broadband Benefit Program is a Federal Communications Commission (FCC) program that provides a temporary discount on monthly broadband bills for qualifying low-income households. Here are some updates:

- Starting on Wednesday May 12, <u>eligible households</u> were able to enroll in the EBB program to receive discounted broadband service -- \$50/month off, and \$75 off on tribal lands. Residents can determine eligibility and apply at <u>GetEmergencyBroadband.org</u>, or through an <u>approved</u> <u>provider</u>.
- <u>EBB communication toolkit materials</u> are now available for download. The toolkit is a collection of social media, printables, and other content to assist libraries and school districts with raising program awareness in their communities.
- DPI will provide an <u>EBB registration webinar</u> at 1 p.m. on May 19, where they will share ideas on how libraries can promote the program and set up EBB registration events.
