4) 2021 Wisconsin Public Library Annual Report Updates

The following is from Michael Dennison of Wisconsin Department of Public Instruction's Division for Libraries and Technology.

I want to inform you of a series of updates that were approved for the 2021 Federal Public Libraries Survey which all Wisconsin public libraries participate in through your responses on the Wisconsin Public Library Annual Report. This 2021 Public Libraries Survey (PLS) New/Revised Data Elements document provides a basic overview of updates to the Federal Public Libraries Survey that we aim to incorporate into the 2021 annual report if they are not already part of the Wisconsin Public Library Annual Report. We understand that the timing of the release of these data elements does not provide time to start collecting from the beginning of the year, but it does give you an opportunity to begin thinking about revising the ways you track some information now.

While these updates will be made available on the 2021 annual report to allow you to provide more detailed information about your library's services, we understand that many libraries do not track some of

these elements to this level of detail yet. We will provide as much guidance and as many tools and resources as we can to help you respond to the data elements in the annual report.
