# V-Cat Bibliographic and Interface Committee Meeting Report January 24 2023 Meeting was held by in the WVLS Office and remotely via GoTo Meeting.

Meeting was called to order by Chair C. Luebbe at 10:02 a.m.

## Aspen update

## Larger print

- Example: An Alaskan family Christmas / Beth Carpenter. b17596257
- Library of Congress large print standard minimum is 14 pt. type. OCLC documentation agrees, but adds the following sentence: "Items labeled "large print" or "larger print," regardless of font size, should also be coded as large print." This creates/allows for inconsistency in MARC records – virtually any material can be coded "large print" so long as the publisher labels it so.
- V-Cat obtains most of its MARC records from OCLC.
- Harlequin is an example of a publisher marketing 13.5 pt. "Larger print" books.
- An unknown number of "Larger print" books display in Aspen as "Large print."
- Choices:
  - o Change V-Cat recommendation for large print from 14 pt. to 13.5 pt.
  - o Edit Bib records in Sierra. Removal of MARC field 008 position 23 "Form" *d Large print* from appropriate bibs will cause them to display in Aspen as "book".
- Consensus of the committee was that changing the V-Cat recommendation will only create confusion. Moving forward, we will work to train V-Cat catalogers in making the edit to the 008 field at the point of cataloging.
- Still to be determined: whether previously cataloged bibs can be updated via Global Update, or if it will need to be done individually.

#### Blu-ray/DVD combo format display

- The simplest way to cause Aspen to display Blu-ray/DVD combos AS combos appears to be to use a 250 Edition Statement in the bib, however the format OF the Edition statement matters:
  - o 250 Edition: **Blu-ray/DVD combo** = inconsistent Aspen display.
  - 250 Edition: Blu-ray + DVD [combo pack] = consistent Aspen display.
  - o Perhaps Aspen doesn't recognize the "/" as an "AND" or "+" sign.
- Also, in bibs where more than one Edition statement is present, it appears that the ORDER of the Edition statements matters:
  - Edition 250 Special edition
  - Edition 250 Blu-ray/DVD combo = inconsistent Aspen display.
  - Perhaps Aspen only considers the 1<sup>st</sup> edition statement listed.
- Aspen determines format from multiple fields, including 538, 500, 300, 250, and 007.
- Rachel has added to 2 007 fields to the MARC alert templates for Blu-ray + DVD combos:
  - o 007 Format s Blu-ray disc
  - o 007 Format v DVD
- Example of a title which displays correctly in all formats: "Sing 2".
- Rachel is going to request a meeting with Aspen to learn more.

 Catalogers are asked to please check Aspen display when cataloging new Blu-ray/DVD combo items.

## Board books/Big books

- Aspen recently added a Board book format, but has no Big book format.
- Example: "Goodnight, moon."
- Risk: Patron searches the title and places a hold from the first screen without expanding to "Show Editions". They may potentially receive any copy in that group, including the Big book edition.
- However, Aspen looks at the editions with the most copies *first* when placing holds. Only on not finding an available copy will it move down to bibs with fewer copies.
- Rachel will ask Aspen to add a Big book format.
- We will rely on patron education for now.

## **Diacritics update**

- 2 possible approaches to fixing diacritical errors in the catalog:
  - Mapping
  - Overlay
- BackStage is using the mapping approach.
- Next step: the completed mapping needs review by Rachel.

#### Report of the ILS Support Specialist

- Added to list of monthly cleanup tasks:
  - Items marked for deletion (approx. 6000/month): Rachel is exporting the items' location codes in order to help V-Cat libraries track the types of items they are discarding.
- LSTA Cooperative Cataloging Grant
  - Group is currently working to understand how everyone catalogs and what language is used.
  - Cooperative cataloging (used by V-Cat) is the opposite of Central cataloging (used by the majority of libraries in Wisconsin).
  - Also working on inclusivity in Subject Headings and Author Authorities.
