4) The Role of Public Libraries and Free Programs

Library programs, provided freely to all, ensure that everyone, regardless of socioeconomic status, can connect to valuable resources. Doing so makes the library's services more accessible and inclusive. Wisconsin firmly upholds the importance of providing unrestricted access to knowledge and ideas for its residents. According to Wisconsin Statute 43.52(2), every public library must be freely accessible for use by the inhabitants of the municipality where it is established and maintained. The law mandates that library programs be accessible to all. While libraries have the authority to charge user fees for non-"core" library services, they are prohibited from imposing any charges that obstruct access to information, including programs.
