

## 1) IMLS Executive Order Update

On Friday, March 14, President Donald Trump signed <u>an executive order</u> regarding the Institute of Museum and Library Services (IMLS), and six other federal agencies. On Thursday, March 20, IMLS <u>issued this statement</u> after a new Acting IMLS Director was appointed by the President.

In its effort to demonstrate the impact IMLS funding has on library services, the Department of Public Instruction is asking library staff and library users to create brief video "testimonials" on the importance of libraries. Videos may be recorded on a cell phone, computer, or tablet. Ideally, the video would be about 30-45 seconds (up to 1 minute maximum) and would speak to the importance of federal funding as it relates to public libraries (e.g., literacy, job search resources, interlibrary loan, eBooks/eAudio materials). Videos can be recorded either vertically or horizontally. To submit the video, <u>complete this Google Form</u>.

Videos submitted will be compiled and published on the DPI's social media pages. Following are prompts to consider using for a video testimonial:

- What does your public library mean to you?
- What service or library program do you rely on regularly and why?
- What if that service or library program went away? How would that impact your life?
- How has the public library changed your life?

WVLS will coshare updates and next steps as they occur.

## 2) Delivery Service Update

WVLS has been working with our new vendor, Purple Mountain, for just over a month. Some reminders:

- Delivery days are not made up when a library is closed. This includes closures due to holidays, inclement weather, staff development, and library maintenance work.

#### • 2025 Summer Math Adventure Grant Due on Thursday

The 2025 Summer Math Adventure Grant offers five WVLS libraries up to \$1,000 in funding and 10 free booklets per age group to enhance math-focused learning this summer!

Based on the <u>Wisconsin Mathematics Council's program</u>, the Summer Math Adventure engages students from Preschool through 8th grade with fun, age-appropriate challenges. Participants complete 12 math activities, earning awards along the way while developing essential math skills. Grant funds can be used for printing materials, marketing, program development, incentives, and math-related resources such as books, puzzles, and games.
